**BY PURCHASING THE FLAT FEE MLS SERVICE THROUGH PARTNERS INVESTMENT PROPERTIES, LLC YOU HEREBY AGREE TO THE FOLLOWING TERMS AND CONDITIONS**

3. Once we receive your property detail sheet we will post your property to the Multiple Listing Service (MLSPIN) and/or Rhode Island State-Wide MLS and also provide the following:
  - a. Realtor® MLS listing (MLSPIN) (**until sold**) (MLSPIN requests only)
  - b. Realtor.com listing (**until sold**)
  - c. RILiving.com (**until sold**)\* (Note: This site is only available if you sign up for your property to be posted to *Rhode Island State-Wide Multiple Listing Service*)
  - d. Your property for sale listed on Boston.com, Homefind.com, etc. (MLSPIN Only)
